Blue Line is an underground railway system covering a distance of 20 kilometers between Hua Lamphong and Bang Sue Station through 18 metro stations. Its MRT Purple Line covers 22 kilometers of distance through 16 stations. BMCL operates with a total of 19 trains across two main lines. Furthermore, the company provides rental space for retail shops manages advertising panels and maintains telecommunication systems and equipment in its metro stations. BMCL is headquartered in Bangkok, Thailand.
