Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the banks industry and had a total market value of \$67,968.4 billion in 2023. China was the fastest growing country with a CAGR of 11.2% over the 2019-23 period.

Within the banks industry, China is the leading country among the BRIC nations with market revenues of \$61,142.6 billion in 2023. This was followed by India, Brazil and Russia with a value of \$3,234.5, \$1,911.8, and \$1,679.5 billion, respectively.

China is expected to lead the banks industry in the BRIC nations with a value of \$80,551.1 billion in 2028, followed by India, Brazil, Russia with expected values of \$4,474.0, \$2,541.0 and \$2,150.1 billion, respectively.
