### **SUMMARY**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The banks industry within the NAFTA countries had a total market value of \$26,016.5 billion in 2020. The Canada was the fastest growing country, with a CAGR of 6.8% over the 2016-20 period.

Within the banks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$20,632.5 billion in 2020. This was followed by Canada and Mexico, with a value of \$4,964.5 and \$419.5 billion, respectively.

The US is expected to lead the banks industry in the NAFTA bloc, with a value of \$26,548.1 billion in 2025, followed by Canada and Mexico with expected values of \$6,401.7 and \$543.6 billion, respectively.
