The beer & cider industry within the NAFTA countries had a total market value of \$1,71,114.4 million in 2023.The Mexico was the fastest growing country, with a CAGR of 8.2% over the 2019-23 period.

Within the beer & cider industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,21,396.4 million in 2023. This was followed by Mexico and Canada, with a value of \$34,277.2 and \$15,440.8 million, respectively.

The US is expected to lead the beer & cider industry in the NAFTA bloc, with a value of \$1,41,655.8 million in 2028, followed by Mexico and Canada with expected values of \$49,486.6 and \$18,680.3 million, respectively.
