The Belgian food & grocery retail market had total revenues of \$56.6 billion in 2022, representing a compound annual growth rate (CAGR) of 3.4% between 2017 and 2022.

The food segment accounted for the market's largest proportion in 2022, with total revenues of \$40.0 billion, equivalent to 70.6% of the market's overall value.

The growth in the Belgian food & grocery retail market is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, according to the National Bank of Belgium, Belgium's consumer confidence indicator rose to -5 in September 2023 from -27 in October 2022.
