The Belgian non-life insurance market had total gross written premiums of \$13.9 billion in 2022, representing a compound annual growth rate (CAGR) of 3.4% between 2017 and 2022.

The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$4.5 billion, equivalent to 32.7% of the market's overall value.

The flood disaster in 2021 that devastated most of Belgium resulted in significant material destruction in addition to a tremendous deal of human misery. These natural disasters are propelling the demand for property insurance.
