SUMMARY

BPO Services in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Asia-Pacific BPO services market had total revenues of \$126,743.9m in 2020, representing a compound annual growth rate (CAGR) of 1.8% between 2016 and 2020.

The Procurement BPO segment was the market's most lucrative in 2020, with total revenues of \$31,904.0m, equivalent to 25.2% of the market's overall value.

BPO services in the region have shrunk since 2016 with the Chinese market shrinking by 2.7% in that time
