## Summary

The total value of the market represents the demand for the service coming from a particular country.

The Asia-Pacific BPO services market is expected to generate total revenues of \$74.5bn in 2020, representing a compound annual growth rate (CAGR) of 1.5% between 2016 and 2020.

The HR outsourcing segment is expected to be the market's most lucrative in 2020, with total revenues of \$20.7bn, equivalent to 27.7% of the market's overall value.



A decline of 7.8% is anticipated in 2020 as a result of the COVID-19 pandemic.
