### **SUMMARY**

BPO Services in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The German BPO services market had total revenue of \$13.8bn in 2020, representing a compound annual growth rate (CAGR) of 4.1% between 2016 and 2020.

The HR Outsourcing segment was the market's most lucrative in 2020, with total revenue of \$4.2bn, equivalent to 30.2% of the market's overall value.

The market experienced significant decline of 7% in 2020, primarily due to the COVID-19 pandemic, which caused large declines in business activity across economies
