Summary

BPO Services in Germany industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). Key Highlights

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The German BPO services market is expected to generate total revenues of \$12.7bn in 2020, representing a compound annual growth rate (CAGR) of 2.5% between 2016 and 2020.

The HR outsourcing segment is expected to be the market's most lucrative in 2020, with total revenues of \$4.4bn, equivalent to 34.6% of the market's overall value.

Demand for BPO services remained strong in 2019 in spite of the anaemic



growth of the German economy. A tighter labor market and strong demand from the manufacturing sector drove revenue growth for HR and vertical-specific BPO services.
