Summary

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Mexican BPO services market is expected to generate total revenues of \$2.4bn in 2020, representing a compound annual growth rate (CAGR) of 0.7% between 2016 and 2020.

The vertical-specific BPO segment is expected to be the market's most lucrative in 2020, with total revenues of \$0.6bn, equivalent to 25.8% of the market's overall value.

The growth of outsourcing activities has been driven by the solid growth of the



Mexican economy and the increasing digitalization of smaller businesses.
