### **SUMMARY**

BPO Services in the Netherlands industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). ### **KEY HIGHLIGHTS**

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Dutch BPO services market had total revenue of \$6.2bn in 2020, representing a compound annual growth rate (CAGR) of 7.5% between 2016 and 2020.

The HR Outsourcing segment was the market's most lucrative in 2020, with total revenue of \$2.6bn, equivalent to 41.8% of the market's overall value.

The market's growth in 2020 came despite the recessionary impacts of the COVID-19 pandemic.
