#### **SUMMARY**

BPO Services in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Scandinavian BPO services market had total revenue of \$5.9bn in 2020, representing a compound annual growth rate (CAGR) of 6.3% between 2016 and 2020.

The Vertical-specific BPO segment was the market's most lucrative in 2020, with total revenue of \$1.5bn, equivalent to 25.7% of the market's overall value.



The market value grew significantly in 2020, despite the COVID-19 pandemic
