## Summary

The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Scandinavian BPO services market is expected to generate total revenues of \$5.1bn in 2020, representing a compound annual growth rate (CAGR) of 2.6% between 2016 and 2020.

The HR outsourcing segment is expected to be the market's most lucrative in 2020, with total revenues of \$1.6bn, equivalent to 30.6% of the market's overall value.

Moderate growth of the economies of this region has driven the growth of HR



services, which comprises the most lucrative segment of this market.
