SUMMARY

BPO Services in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Singaporean BPO services market had total revenue of \$3.3bn in 2020, representing a compound annual growth rate (CAGR) of 13.5% between 2016 and 2020.

The Vertical-specific BPO segment was the market's most lucrative in 2020, with total revenue of \$1.0bn, equivalent to 29.7% of the market's overall value.

The market's growth was spurred by the remote working possibilities of the pandemic.
