The bpo services industry within the NAFTA countries had a total market value of \$1,19,802.0 million in 2023. The Mexico was the fastest growing country, with a CAGR of 7.4% over the 2019-23 period.

Within the bpo services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,06,487.2 million in 2023. This was followed by Canada and Mexico, with a value of \$8,747.0 and \$4,567.8 million, respectively.

The US is expected to lead the bpo services industry in the NAFTA bloc, with a value of \$1,21,452.4 million in 2028, followed by Canada and Mexico with expected values of \$10,667.6 and \$5,736.2 million, respectively.
