SUMMARY

Air Freight in Brazil industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-22, and forecast to 2027). KEY HIGHLIGHTS

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Brazilian air freight sector had total revenues of \$803.5 million in 2022, representing a compound annual growth rate (CAGR) of 0.1% between 2017 and 2022.

Sector consumption volumes declined with a CAGR of negative 4.2% between 2017 and 2022, to reach a total of 1.4 billion FTK in 2022.

According to the Brazilian Institute of Geography and Statistics, consumer spending in Brazil has been increasing since the second half of 2022 and it reached BRL1,666.7 billion (\$308.9 billion) in the fourth quarter of 2022. This has helped in increasing the demand for goods, which has contributed to the growth in the air freight sector.
