SUMMARY

Breakfast Cereals in France industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2014-18, and forecast to 2023). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The breakfast cereals market consists of retail sales of hot cereals and ready-to-eat cereals. Hot cereals segment consists of traditional products (e.g. porridge oats), instant mixes and ready-to-heat products. Ready-to-eat cereals segment consists of children's breakfast cereals and family breakfast cereals such as, flakes, muesli and other RTE cereals. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2018 exchange rates.

The French breakfast cereals market had total revenues of \$994.5m in 2018, representing a compound annual growth rate (CAGR) of 2.4% between 2014 and 2018.

Market consumption volume increased with a CAGR of 1.9% between 2014 and 2018, to reach a total of 131.2 million kilograms in 2018.

Increasingly, French consumers are concerned about their wellbeing, a situation

that has led to the popularity of products that can claim health benefits.
