Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the healthcare providers industry and had a total market value of \$1,638.3 billion in 2021. Brazil was the fastest growing country with a CAGR of 11.9% over the 2017-21 period.

Within the healthcare providers industry, China is the leading country among the BRIC nations with market revenues of \$1,222.9 billion in 2021. This was followed by Brazil, Russia and India with a value of \$227.3, \$94.5, and \$93.6 billion, respectively.

China is expected to lead the healthcare providers industry in the BRIC nations with a value of \$1,795.5 billion in 2026, followed by Brazil, India, Russia with expected values of \$301.5, \$129.9 and \$126.7 billion, respectively.
