Within the healthcare providers industry, China is the leading country among the BRIC nations with market revenues of \$1,225.7 billion in 2022. This was followed by Brazil, Russia and India with a value of \$200.6, \$103.4, and \$95.3 billion, respectively.

China is expected to lead the healthcare providers industry in the BRIC nations with a value of \$1,616.5 billion in 2027, followed by Brazil, India, Russia with expected values of \$286.4, \$117.5 and \$113.1 billion, respectively.
