Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the transportation services industry and had a total market value of \$837,426.6 million in 2021. China was the fastest growing country with a CAGR of 6.3% over the 2017-21 period.

Within the transportation services industry, China is the leading country among the BRIC nations with market revenues of \$576,234.1 million in 2021. This was followed by India, Brazil and Russia with a value of \$136,727.2, \$96,378.9, and \$28,086.3 million, respectively.

China is expected to lead the transportation services industry in the BRIC nations with a value of \$677,371.5 million in 2026, followed by India, Brazil, Russia with expected values of \$173,956.8, \$104,634.5 and \$34,628.5 million,



respectively.
