The TV advertising segment accounted for the market's largest proportion in 2023, with total revenues of \$12.7 billion, equivalent to 86.3% of the market's overall value.

In 2023, the revenue of the Indonesian broadcasting & cable TV market witnessed an annual growth of 5.1% due to the rise in Pay TV subscriptions. According to GlobalData, in 2023, the total Pay TV subscriptions in Indonesia reached 25.6 million.
