The TV subscriptions segment accounted for the market's largest proportion in 2023, with total revenues of \$5.2 billion, equivalent to 60.3% of the market's overall value.

In 2023, the revenue of the Scandinavian broadcasting & cable TV market witnessed an annual growth of 2.9%, mainly driven by the rise in TV License or Public funds and a substantial growth in Pay TV subscriptions.
