The Singaporean broadcasting & cable TV market recorded revenues of \$0.9 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.8% between 2018 and 2023.

The TV advertising segment accounted for the market's largest proportion in 2023, with total revenues of \$0.5 billion, equivalent to 61% of the market's overall value.

The contraction of the Singaporean broadcasting & cable TV market during 2018-23 is attributed to the decline in Pay TV subscriptions. According to GlobalData, in 2023, the total Pay TV subscriptions in Singapore reached 548,600.
