The Turkish broadcasting & cable TV market recorded revenues of \$0.6 billion in 2023, representing a negative compound annual growth rate (CAGR) of 19.7% between 2018 and 2023.

The TV subscriptions segment accounted for the market's largest proportion in 2023, with total revenues of \$283.4 million, equivalent to 46.1% of the market's overall value.

In 2023, the revenue of the Turkish broadcasting & cable TV market witnessed an annual contraction of 3.0% due to the increased competition from social media, video games, and user-generated content platforms such as YouTube, which diverted attention from traditional TV.
