SUMMARY

The broadcasting & cable TV market consists of all terrestrial, cable and satellite broadcasters of digital and analog television programming.

The Asia-Pacific broadcasting & cable TV market had total revenues of \$135,243.6m in 2020, representing a compound annual growth rate (CAGR) of 2.1% between 2016 and 2020.

The TV advertising segment was the market's most lucrative in 2020, with total revenues of \$62,499.4m, equivalent to 46.2% of the market's overall value.

A number of markets in this region saw decline in 2020 amid the COVID-19 pandemic. Both Pay-TV and advertising revenues tumbled, with high unemployment reducing spend on TV subscriptions, while advertisers tightened spend in a bid to ride out the economic turbulence brought about by COVID-19.
