The Dutch broadcasting & cable TV market had total revenues of \$4,170.2m in 2020, representing a compound annual growth rate (CAGR) of 1.4% between 2016 and 2020.

The TV subscriptions segment was the market's most lucrative in 2020, with total revenues of \$2,113.6m, equivalent to 50.7% of the market's overall value.

Younger age groups are using substitutes, such as gaming or streaming shows, and mediums such as Netflix and Amazon Prime, more than older citizens, and this has hindered growth in this market.
