The TV subscriptions segment accounted for market's the largest proportion in 2022, with total revenues of \$6.0 billion, equivalent to 70.2% of the market's overall value.

High competition from subscription video-on-demand (SVoD) services further contributed to the decline in cable TV. According to GlobalData in 2022, SVoD penetration surged to reach 127%.
