SUMMARY

The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$21.3 billion, equivalent to 43.5% of the market's overall value.

The Canadian chemicals market is much smaller than that of its neighbor the US, accounting for just 7.1% of the North American region's total value.
