Canada Marine Freight Market to 2027

### Summary

Marine Freight in Canada industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2017-22, and forecast to 2027). ### **Key Highlights**

The marine freight sector includes revenues generated from the transportation of containers (only LoLo) and dry bulk cargo by sea and ocean-going vessels. The sector encompasses domestic and international freight, which, for the purposes of this report, is counted in the country of origin.

The Canadian marine freight industry had total revenues of \$12.7 billion in 2022, representing a compound annual growth rate (CAGR) of 1.1% between 2017 and 2022.

The containerized segment accounted for the industry's largest proportion in 2022, with total revenues of \$11 billion, equivalent to 86.8% of the industry's overall value.

Canada accounted for a 5.3% share of the North American marine freight industry in 2022.
