### SUMMARY

Car Manufacturing in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2015-19, and forecast to 2024). The Scandinavian car manufacturing industry had total revenues of \$5.7bn in 2019, representing a compound annual growth rate (CAGR) of 9.3% between 2015 and 2019.

Industry production volume increased with a CAGR of 10.5% between 2015 and 2019, to reach a total of 342.8 thousand units in 2019.

Finland and Sweden are the only two countries with car manufacturing operations in this industry. Growth has been driven by Finland, which has seen impressive growth, while Sweden's car manufacturing industry has been sluggish overall.
