### Summary

### Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The car manufacturing industry within the NAFTA countries had a total market value of \$312.9 billion in 2023. The US was the fastest growing country, with a CAGR of 9.3% over the 2019-23 period.

Within the car manufacturing industry, the US is the leading country among the NAFTA bloc, with market revenues of \$228.8 billion in 2023. This was followed by Mexico and Canada, with a value of \$57.1 and \$26.9 billion, respectively.

The US is expected to lead the car manufacturing industry in the NAFTA bloc, with a value of \$389.1 billion in 2028, followed by Mexico and Canada with expected values of \$76.0 and \$30.2 billion, respectively.
