Among the G8 nations, the US is the leading country in the casinos & gaming industry, with market revenues of \$1,03,554.0 million in 2016. This was followed by Japan and Italy, with a value of \$35,181.4 and \$16,074.4 million, respectively.



The US is expected to lead the casinos & gaming industry in the G8 nations with a value of \$1,09,167.9 million in 2016, followed by Japan and Canada with expected values of \$39,267.9 and \$17,660.8 million, respectively.
