The Singaporean casinos & gaming sector recorded total revenues of \$5.2 billion in 2023, representing a negative compound annual growth rate (CAGR) of 1% between 2018 and 2023.

The casinos segment accounted for the sector's largest proportion in 2023, with total revenues of \$3.1 billion, equivalent to 60.5% of the sector's overall value.

The Singaporean casinos & gaming market held a 7.1% share of the Asia-Pacific market in 2023.
