The casinos segment accounted for the sector's largest proportion in 2023, with total revenues of \$126,958.8 million, equivalent to 74.3% of the sector's overall value.

According to the American Gaming Association, Americans invested an overall \$119.8 billion on sports betting in 2023, rising 27.5% from 2022, reaching new heights in 2023.
