The casinos & gaming industry within the NAFTA countries had a total market value of \$1,20,548.7 million in 2016. The Mexico was the fastest growing country, with a CAGR of 6.7% over the 2012-16 period.

Within the casinos & gaming industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,03,554.0 million in 2016. This was followed by Canada and Mexico, with a value of \$13,985.3 and \$3,009.5 million,

respectively.

The US is expected to lead the casinos & gaming industry in the NAFTA bloc, with a value of \$1,09,167.9 million in 2021, followed by Canada and Mexico with expected values of \$17,660.8 and \$4,433.0 million, respectively.
