Within the casinos & gaming industry, China is the leading country among the top 5 emerging nations, with market revenues of \$55,079.4 million in 2016. This was followed by India and Mexico with a value of \$6,256.5 and \$3,009.5 million, respectively.



China is expected to lead the casinos & gaming industry in the top five emerging nations, with a value of \$65,776.2 million in 2021, followed by India and Mexico with expected values of \$7,806.0 and \$4,433.0 million, respectively.
