The casinos & gaming market values are stated in terms of gross gambling yield (GGY). It is the amount of money retained by the casino and gaming operators after winnings amounts have been paid and before operating costs are deducted. The market covers all forms of betting and gaming.

The European casinos & gaming sector had total revenues of \$105.8 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.

The casinos segment accounted for the sector's largest proportion in 2023, with total revenues of \$37.4 billion, equivalent to 35.3% of the sector's overall value.

The UK casinos & gaming sector held an 18.4% share of the European market in 2023 followed by Italy with an 18.2% share.
