As of June 2023, the Oxley Potassium Nitrate project contains mineral resources of 154.7 million tonnes (Mt) at 8.3% potassium oxide (K2O) with cutoff grade of 6% K2O. As of June, 2023, Ardmore Phosphate Rock project had mineral resources of 15.8 Mt at 27.8% P2O5 using a 16% P2O5 cut-off. It has access to existing roads, rail, power, and gas infrastructure. Centrex is headquartered in Adelaide, South Australia, Australia.
