The Asia-Pacific cereal crops industry had total revenues of \$378.6bn in 2020, representing a compound annual growth rate (CAGR) of 3.3% between 2016 and 2020.

Industry production volume increased with a CAGR of 0.8% between 2016 and 2020, to reach a total of 1,099.7 million tonnes in 2020.

81% of rice traded on global markets is grown in Asia while 90% of the world's rice is produced and consumed in the Asia-Pacific region.
