The commodity chemicals segment was the market's most lucrative in 2020, with total revenues of \$78.3bn, equivalent to 46.1% of the market's overall value.

Germany's chemicals market is the largest in Europe (accounting for 21.5% of its total value in 2020) and the third largest in the world. Its location provides an



ideal trading hub for the rest of Europe while also attracting some of the most highly trained scientists.
