#### SUMMARY

The Dutch chemicals market had total revenues of \$54.4bn in 2020, representing a compound annual rate of change (CARC) of -1.8% between 2016 and 2020.

The commodity chemicals segment was the market's most lucrative in 2020, with total revenues of \$18.9bn, equivalent to 34.7% of the market's overall value.

Commodity chemicals have a large share of the Dutch chemicals market. This is unsurprising as commodity chemicals are typically low-cost, high volume



products that suit an economy such as the Netherlands.
