#### SUMMARY

The commodity chemicals segment was the market's most lucrative in 2019, with total revenues of \$337.2bn, equivalent to 47.9% of the market's overall value.

The US is by far the largest market within the North America region, accounting for 90.2% of its total value in 2019. As a result, its performance is reflected heavily in the region's as a whole.
