The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The chemicals industry within the NAFTA countries had a total market value of \$708.3 billion in 2023. The Canada was the fastest growing country, with a CAGR of 7.4% over the 2019-23 period.

Within the chemicals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$633.6 billion in 2023. This was followed by Canada and Mexico, with a value of \$42.3 and \$32.4 billion, respectively.

The US is expected to lead the chemicals industry in the NAFTA bloc, with a value of \$768.9 billion in 2028, followed by Canada and Mexico with expected values of \$64.1 and \$34.0 billion, respectively.
