#### SUMMARY

The NAFTA Chemicals industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). #### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The chemicals industry within the NAFTA countries had a total market value of \$679.0 billion in 2020. The Canada was the fastest growing country, with a CAGR of 4.5% over the 2016-20 period.

Within the chemicals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$613.2 billion in 2020. This was followed by Canada and Mexico, with a value of \$44.8 and \$21.0 billion, respectively.

The US is expected to lead the chemicals industry in the NAFTA bloc, with a value of \$676.5 billion in 2025, followed by Canada and Mexico with expected values of \$54.9 and \$26.5 billion, respectively.
