The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Chinese BPO services market had total revenues of \$22,276.6 million in 2021, representing a compound annual growth rate (CAGR) of 6.7% between 2016 and 2021.

The vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$5,803.3 million, equivalent to 26.1% of the market's overall value.

Low labor cost combined with highly skilled labor made China one of the top destinations for outsourcing of business process by business leaders to achieve quality work at minimal costs.
