The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Chinese BPO services market had total revenues of \$32.3 billion in 2022, representing a compound annual growth rate (CAGR) of 6.9% between 2017 and 2022.

The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$8.8 billion, equivalent to 27.3% of the market's overall value.



Low labor costs combined with highly skilled labor make China one of the top destinations for outsourcing business processes by business leaders to achieve quality work at minimal costs.
