Summary

The Scandinavian civil engineering sector is expected to generate total revenues of \$26.1bn in 2020, representing a compound annual growth rate (CAGR) of 0.3% between 2016 and 2020.

During their enforced lockdown periods, Scandinavian countries have seen a great deal of public investment diverted towards healthcare and emergency measures.

The wider economic impact of the COVID-19 pandemic will almost certainly lead

to suppressed growth in the forecast period.
