Civil Engineering in Singapore

Summary

Civil Engineering in Singapore industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

Key Highlights

The civil engineering industry includes construction work classified as civil engineering (i.e. non-buildings), excluding companies working in the home-building subsector. The market value is calculated as the value of the construction of non-buildings. Where possible values are not adjusted seasonally. All currency conversions have been calculated using constant average 2019 annual rate.

The Singaporean civil engineering sector is expected to generate total revenues of \$6.8bn in 2020, representing a compound annual growth rate (CAGR) of 8.5% between 2016 and 2020.

Opportunities to bring forward work on major civil infrastructure projects have served to offset the worst effects of COVID-19 on infrastructure investment, and has enabled the sector to continue to grow in 2020.

The wider economic impact of the COVID-19 pandemic will almost certainly lead

to less strong growth in the forecast period.
