These countries contributed \$1,238.7 billion to the global civil engineering industry in 2017, with a compound annual growth rate (CAGR) of 10.6% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$1,702.1 billion in 2022, with a CAGR of 6.6% over the 2017-22 period.

Within the civil engineering industry, China is the leading country among the top 5 emerging nations, with market revenues of \$953.4 billion in 2017. This was followed by India and Brazil with a value of \$220.0 and \$43.2 billion, respectively.



China is expected to lead the civil engineering industry in the top five emerging nations, with a value of \$1,366.3 billion in 2022, followed by India and Brazil with expected values of \$269.6 and \$39.0 billion, respectively.
